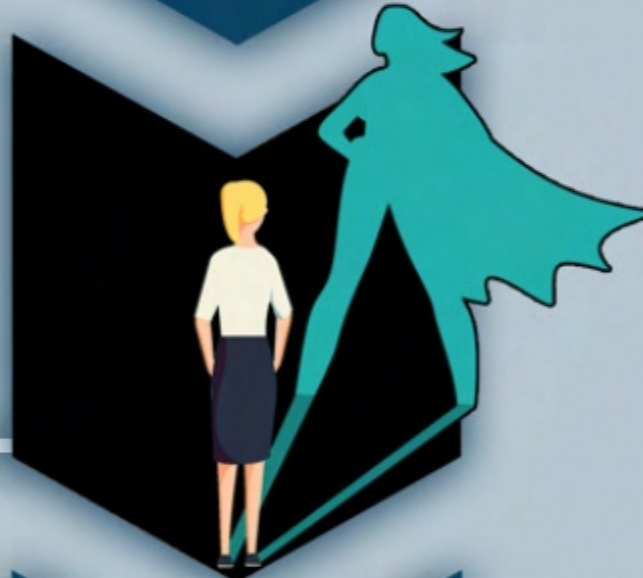

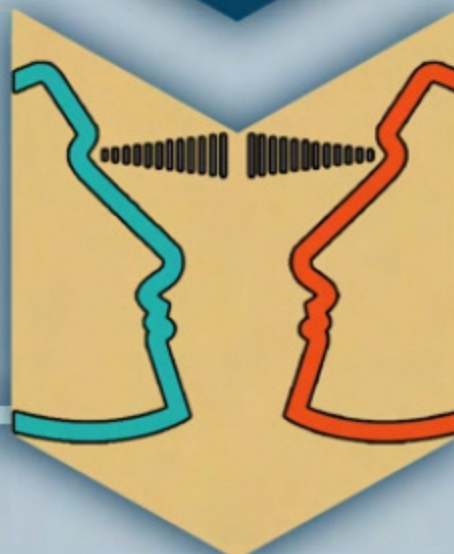

WHAT ARE THE GROUNDS FOR DIVORCE?

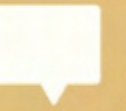


- Willful desertion or abandonment
- Cruelty and reasonable apprehension of bodily harm
- Separation divorce (AKA a “no-fault” divorce)
- Adultery, sodomy, or buggery
- Conviction of a felony

HOW IS PROPERTY DIVIDED?



Property can be divided in two ways: Marital property is acquired or earned during marriage. Separate property belonged to either spouse prior to marriage. However, property that was received as a gift or inherited during or prior to a marriage is also separate property.



WHEN IS SPOUSAL SUPPORT AWARDED?

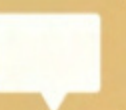


Only when it's necessary. Generally, courts award support in long-term marriages, if the spouses had a large gap in income, or if one spouse has a disability or doesn't have a job.

WHO RECEIVES CUSTODY OF THE CHILDREN?



The court will look at all the factors in the child's current situation before deciding which parent to award custody to. The most important factor is what is in the child's best interest.
